

NOTICE REGARDING BACKGROUND REPORTS

In connection with your application for lease contract with Moving Performance, LLC, it may obtain one or more reports regarding your credit, driving, and/or criminal background history from a consumer reporting agency and/or other sources. If Moving Performance, LLC uses any information it obtains from a background report in a decision to not lease contract or to make any other adverse lease contract decision regarding you, Moving Performance, LLC will provide you with a copy of the report upon which its decision was based and a written summary of your rights under the Fair Credit Reporting Act before taking any final adverse action. If any final adverse action is taken against you based upon a background report, Moving Performance, LLC will notify you that the action has been taken and that the background report was the reason for the action. Moving Performance, LLC cannot obtain background reports from consumer reporting agencies or other sources regarding you unless you consent in writing. If you agree that Moving Performance, LLC may obtain such background reports, please read the following and sign below:

I authorize Moving Performance, LLC to contact any organization or individual that I have listed on my application or resume or mentioned in lease interviews and obtain from them any relevant information about my lease qualifications, including my experience, skills, and abilities. I understand that I am consenting to the release of safety performance information including crash data from the previous five (5) years and inspection history from the previous three (3) years, as well as any reference-related information about me held or known by my former lease contractors, employers, supervisors, and co-workers. In addition, I consent to the release of any information about my education, experience, abilities, or lease-related/work-related characteristics or traits held or known by other organizations or individuals, including schools and educational institutes, professional or business associates, and friends and acquaintances that Moving Performance LLC might contact in the course of conducting a reference check or background investigation of my suitability for lease contract.

I understand and acknowledge that this release of information can involve my qualifications, performance, credentials, or other characteristics or factors affecting my suitability for lease contract with Moving Performance, LLC. Specifically, I am authorizing the release of any information about my performance, experience, capability, attitude, specific events, or other lease-related/work-related characteristics that currently are in the possession of the requested organizations or their managers or representative.

In exchange for Moving Performance, LLC's consideration of my application, I agree not to file or pursue any complaints, claims, or legal actions of any kind against any organization or individual that provides lease-related/work-related information about me to Moving Performance, LLC or its agents in accordance with the terms and intent of this release. I also agree not to file or pursue any complaints, claims, or legal action against Moving Performance, LLC or any of its employees, representatives, or agents arising out of their efforts to obtain lease-related/work-related information about me.
